

## **Sixth Annual Pro Bono & Community Service Awards**

Among the ways we encourage pro bono and community service as part of our firm culture is to recognize our attorneys and staff who have made outstanding contributions to our communities and to our firm. Our Sixth Annual Pro Bono & Community Service Awards Ceremony, held on February 13, 2020, recognized the efforts of our attorneys and staff in 2019.

### **Lancaster Pro Bono Attorney of the Year**

This award is presented to the attorney who has contributed the highest number of pro bono hours in a year. This year, the award was renamed in honor of longtime partner Ralph I. Lancaster, Jr. who passed away in January 2019 after practicing law at Pierce Atwood for nearly 60 years. Throughout his career, Ralph devoted countless hours to pro bono service for low-income residents of Maine and to many nonprofit and charitable organizations.







### **Lancaster Pro Bono Attorney of the Year**

In 2019, **Donald R. Pinto, Jr.** devoted 244 pro bono hours to Way Finders, Inc., a nonprofit housing organization based in Springfield, Massachusetts. In addition to offering an array of housing-related services to low-income communities, Way Finders develops affordable housing for both rental and ownership under the Massachusetts statute known as Chapter 40B. That statute allows developers of affordable housing to override local zoning and land-use regulations in cities and towns whose housing stock does not meet the statute's threshold of at least 10% affordable units, and enables the construction of multi-family housing in areas where it would not be permitted under local regulations. All of Way Finders' developments consist of 100% affordable units.

Since early 2017, Don has been representing Way Finders on its proposed development of a 43-unit townhouse project in Ludlow, Massachusetts.

Don's work on this project is important because affordable housing is essential – yet in short supply – in eastern Massachusetts, which has some of the highest housing costs in the country.

## **McKusick Community Impact Award**

Named after Vincent Lee McKusick, former Chief Justice of the Maine Supreme Judicial Court and Pierce Atwood attorney and friend for more than 50 years, the McKusick Community Impact Award recognizes one attorney and one staff member annually who have made significant, positive impacts in their communities through pro bono and/or community service. Award recipients select a charitable organization to receive a monetary donation made on their behalf by Pierce Atwood.

Since 2014, attorney **Nick Brown** has worked on behalf of five children who arrived in the U.S. as unaccompanied minors fleeing violent conditions in Central America. These clients came to Pierce Atwood through our partnership with Kids in Need of Defense (KIND). Nick has contributed more than 600 hours on KIND matters since 2014.

When it became clear that Spanish-language legal support was critical to our continued representation of these clients, paralegal **Cindy Shove** joined Nick on the team in 2019. Cindy's efforts have included participating in client meetings, preparing clients for hearings, and translating cover letters, birth certificates, and other legal documents.

At the end of November, thanks to Nick and Cindy's efforts, three of these individuals were granted legal permanent resident (green card) status. Their green cards were issued after more than three years of anxious waiting because of the enormous backlog of Applications to Adjust Status filed by individuals from Central America.

Nick and Cindy's two remaining clients continue to await their hearings as U.S. Citizenship and Immigration Services works to process the applications backlog. We salute Nick and Cindy for their continuing commitment to these vulnerable clients.

## **Scribner Firm Impact Award**

Named for longtime former partner Fred Scribner, whose legacy endures through the firm's commitment to the community, its employees, and the law, this award is given annually to one attorney and one staff member who work to keep pro bono and community service top of mind throughout the firm.

Attorney Ryan Kelley's commitment to pro bono and community service is a model within the firm. He contributes his time, skills, and enthusiasm to a wide range of pro bono and community service initiatives, including serving on the firm's Pro Bono Team; chairing the New Voices Challenge Committee of Maine's 2016 Campaign for Justice; and serving as a leader and mentor for other associates interested in participating in the Maine Association of Nonprofits' Emerging Leaders Program. Outside the firm, Ryan serves on boards and committees for nonprofit organizations, including Northern Light Mercy Hospital, the Pine Tree Council of the Boy Scouts of America, and Jump\$tart Coalition for Personal Financial Literacy, and teaches financial literacy to high school and community college students through Credit Abuse Resistance Education (CARE) and the Boston Bar Association's M. Ellen Carpenter Financial Literacy Program. Ryan is exceptionally active in pro bono matters, particularly for indigent Chapter 7 debtors and creditors, and for guardians ad litem representing abused or neglected children in child protective cases.

The colleague who nominated Ryan wrote: "To me, Ryan represents the best version of what an attorney's pro bono and community service commitment can be, by dedicating time and expertise where it is needed, while maintaining an extremely active law practice. Having role models at Pierce Atwood like Ryan – particularly young lawyers – lights the way for others."

## **Scribner Firm Impact Award**

In recent years, Pierce Atwood has participated in several Court Appointed Special Advocates (CASA) cases. CASA volunteers advocate for abused, neglected, or abandoned children when the state has requested court intervention because their parents are not able to care for them. These cases involved difficult legal issues surrounding the best interest of the children. In each case the firm handled, the CASA volunteer Guardian ad Litem (GAL) sought help from Pierce Atwood to effectively convey their positions through representation. None of this would have been possible without the efforts of Pierce Atwood litigation legal assistant **Denise Plourde**.

Denise learns the files in these cases inside and out, puts in hours creating witness folders with key documents and exhibits, attends trials to help keep the attorneys organized, and combs through thousands of pages of Department of Health and Human Services records to accurately summarize their contents. The positive outcomes achieved in these matters would have been in jeopardy without Denise's superior organization efforts. Denise's colleagues describe her as "indispensable" to the firm's CASA efforts.

## "Know Your Rights" Event

In May, a number of Pierce Atwood attorneys, staff and family members collaborated with the Immigrant Legal Advocacy Project (ILAP) and Maine Law's Immigrant and Human Rights Clinic at a "Know Your Rights" event to provide pro bono legal services to members of Portland's immigrant community.



Once again, Trusts & Estates practice group leader Molly Liddell organized the requisite troops and resources, and together with Business Group partner Emily Cooke provided pro bono legal services to attendees. Immigration attorney Kellie MacDonald and Business Immigration Case Coordinator Meigan Goff provided Spanish-language support to our team and other participating organizations. Trusts & Estates attorney Griff Leschefske and Business attorney Mike Hernandez assisted with advance planning support to help make the event happen. Numerous Pierce Atwood spouses and family members also were there to provide Spanish-language support and camaraderie.

Program organizers tell us that having our attorneys (and their families) show up to an event like this sends a powerful signal of support.

#### **Pro Bono Successes**

- At the invitation of the Hospice of Southern Maine, Jana Magnuson gave a presentation to hospice staff designed to help HSM social workers and nurses understand where legal services can be helpful and to better field patients' basic questions. Since 2014, Jana has been providing basic estate planning services on a pro bono basis to low-income, terminally ill patients referred by HSM's social workers.

- Cheryl Allen-Ricciardi assisted a Rhode

- Dennis Keeler assisted a Maine nonprofit local library with respect to a landlord-tenant question.
- Soyoung Yoon and Suzanne King provided employment advice to Mill City Grows, an organization that creates and manages community gardens for residents and schools in Lowell, Massachusetts.



### **Pro Bono Highlights**



The Immigrant Legal Advocacy Project (ILAP) selected Pierce Atwood as the recipient of its 2019 Pro Bono Firm of the Year Award in appreciation of our commitment to pro bono work on behalf of Maine's indigent foreign-born population in asylum cases.

The award was presented at the Maine State Bar Association's annual meeting on January 31, 2020, and was accepted by **Emily Cooke**, partner in charge of the firm's pro bono program, on behalf of the firm.

## **Community Building**

As part of our commitment to diversity and inclusion, and building a diverse legal community in Maine, Pierce Atwood is pleased to collaborate with Bernstein Shur, Verrill, and University of Maine School of Law on the new **D1L Maine Diversity Summer Associate Program**. Our three firms are together seeking 1L students, who are members of historically underrepresented groups in the legal profession, to apply as a ten-week Maine Diversity Summer Associate in one of our offices in Portland.



The ultimate goal of the program is to increase diversity in the Maine legal market and to build a community of diverse professionals in Maine.

Six 1L students will each receive a job offer from one of the three participating law firms and be hired into the program, a ten-week paid internship, from May 26, 2020 to July 31, 2020. The University of Maine School of Law will serve as the administrator of the 2020 program.

For the first year of the program, applications opened December 15, 2019 and were accepted on a rolling basis through February 3, 2020.



## **Community Service**

As a firm, we hold an annual **Day of Community Service** in each of our offices. Since 2004, attorneys and staff leave the office together for a day to work on service projects for deserving charitable organizations. 2019 marked our 16<sup>th</sup> Annual Day of Community Service. Our projects this year included the following:

#### **Portsmouth**

On September 11, attorneys and staff from the Portsmouth office assisted the **Strafford County Nutrition Program** with their third Annual Appeal to raise money for the Meals on Wheels program, as part of the United Way of the Greater Seacoast's "Day of Caring." Our team helped assemble a 20,000 piece mailing – double the size of last year's mailing.



### **Janet D. Eustis Memorial Volunteer Time-Off Program**

Through our **Janet D. Eustis Memorial Staff VTO Program**, launched in 2014, staff members are given one paid day off each year to volunteer for a nonprofit organization of their choice.

Janet Eustis was a Pierce Atwood legal assistant for 15 years whose commitment to her community inspired everyone who knew her, and whose selflessness reflected the best of our firm's tradition of service.

In 2019, 22 staff members participated in the program.

#### **Portland**

Our Maine attorneys and staff spent the day on May 8 working at the **Salvation Army's Camp Sebago** in Standish, Maine assisting with preparations for opening the camp for the season. Camp Sebago provides a spiritual, educational, nutritional, social, and recreational experience for campers through creative, healthy experiences in cooperative group living in an outdoor setting.

#### **Providence**

On August 7, lawyers and staff from the Providence office provided volunteer services to the **Rhode Island Community Food Bank**, sorting food for distribution and packing summer meal boxes for hundreds of children who might otherwise go without food during the summer recess from school.

With representation for many years on its Board of Directors, Pierce Atwood is a major supporter of the Food Bank, which distributes more than 10 million pounds of food each year, and more than 50,000 meals each month, to food insecure Rhode Island residents, many of whom are children (33%) or seniors (22%). For the past three years the firm has been a sponsor of the Food Bank's annual Empty Bowls event, one of its two major fundraisers each year.



# **Community Service in DC Public Schools**

Pierce Atwood is pleased to provide ongoing support to **Anne Beers Elementary School** in Washington, DC, through the DC Public School Partnership Program of the Washington Lawyers' Committee for Civil Rights and Urban Affairs. This program partners area law firms and businesses with individual DC public schools to bring tutoring, mentoring, and other academic enrichment services to thousands of children. Pierce Atwood and Drinker Biddle & Reath LLP both support Anne Beers.

On May 20, 2019, two teams of 3rd-5th graders from Anne Beers participated in the annual district-wide **GeoPlunge Tournament**. GeoPlunge is a US geography game, and this is the largest tournament in the District school system. Our attorneys and staff participated in team training sessions to help prepare the students. One of our teams was recognized for its teamwork, which is critical to success in the contest. We held an end-of-school year celebration for the teams on June 5. We served pizza and prepared goody bags with books, games, and treats for each student.



At Thanksgiving, in a shared effort with Drinker Biddle, we provided **Thanksgiving food bags** to 20 families from Anne Beers. Each family received two bags with everything but the turkey for a Thanksgiving feast. Natalie Huddleston handled the shopping, Jenekia Shade helped pack the bags, and Randy Rich delivered the food to the school for distribution.



On December 13, Anne Beers held its annual **Scripps Spelling Bee**. More than 35 spellers from grades 2-5 participated. After 14 rounds and a tense spell-off, second grader Alana was this year's winner. Randy Rich reprised his role as pronouncer and Natalie Huddleston offered her encouragement and support from the audience.

## **Charitable Giving**

For 2019, Pierce Atwood's Charitable Giving Committee chose to focus our fundraising efforts on behalf of the **Doug Flutie Jr.**Foundation for Autism.



The foundation was established in 1998 by former quarterback Doug Flutie and his wife Laurie after their son Doug, Jr. was diagnosed with autism at the age of three, to help other people and families affected by autism live life to the fullest. Executive Director Nick Savarese came to Pierce Atwood's Portland office to speak to the firm on March 18 about the foundation's work.

Through the efforts organized by the Charitable Giving Committee, Pierce Atwood attorneys and staff raised \$10,000 for the foundation.

Our fundraising efforts in support of Doug Flutie Jr. Foundation for Autism included:

- Monthly "Jeans Fridays"
- Ice cream sales
- Various raffles, including: holiday baskets, 50/50 raffle, calendar raffle, and a signed Boston Celtics Jayson Tatum jersey
- Charity happy hour at a local restaurant, which donated 60% of happy hour sales

# **Charitable Giving**

More than 250 asylum seekers from Africa, many from Angola and the Democratic Republic of the Congo, who are fleeing violence and persecution, were provided temporary emergency shelter at the Portland Expo Center sports and exposition complex. Since asylum seekers cannot work for a period of time after filing their applications, additional assistance was needed.

Together through this pop-up Jeans Day we raised \$600 dollars to be used to provide food and care to our new neighbors!
