**ORDER APPROVING RECEIVER'S FIFTEENTH INTERIM REPORT AND FOURTEENTH

1. That the Fifteenth Interim Report of Stephen F. Del Sesto, Esq., in his capacity as Temporary and Permanent Receiver herein, and all acts, doings, and disbursements of said Receiver and Special Counsel to date are hereby approved, confirmed and ratified;
2. That the fees, costs and expenses incurred by the Receiver during the period of August 1, 2020 through and including September 30, 2020 (the "Invoice Period") are fair and reasonable;
3. That the Receiver's Fourteenth Interim request for fees, costs and expenses incurred during the Invoice Period in the amount of \$75,074.00 are all hereby approved in full. The Receiver is authorized and directed to pay himself in full from available sources of cash in or held by the Estate;

4. That the Sixteenth Interim Report and Fifteenth Interim Request for Fees of the Receiver will be scheduled for WebEx hearing in December 2020 at a date and time to be docketed;

5. That the Receiver's Bond previously posted in this matter shall remain in place until ordered cancelled by this Court;

6. That this matter shall remain open and the Order Appointing Permanent Receiver entered herein shall remain in full force and effect until further Order of this Court; and

7. The effective date of this Order shall be *nunc pro tunc* as of October 20, 2020.
